The licensing of the BD logo and format specifications does not require that you become a Member.

(5) An application for Membership from an entity (or its affiliates) that uses any company or commercial name, trademark, or domain name that may cause confusion adverse to the success of the Blu-ray Disc Format may, upon notice, be held in abeyance for further review.
